

## ELIGIBILITY WITH CHARITIES AID FOUNDATION AMERICA (CAF AMERICA)

### WHAT DOES IT MEAN TO BE ELIGIBLE?

As a US public charity, CAF America is able to accept donations from US donors who can then recommend that CAF America use those funds to support your organization. Since you are eligible with us, we will be able to make these grants to you. The donations they make are 100% tax deductible, and they will receive a tax receipt from CAF America for the full amount of their donation.

CAF America can also accept donations of real property. Please contact us for additional information and pricing pertaining to real property.

### HOW CAN OUR ORGANIZATION RECEIVE DONATIONS ONCE WE'RE ELIGIBLE?

#### By check:

1. Write a check payable to CAF America
2. The attached gift form is required for any gifts not made through our online donation form.
3. Mail the check and gift form to:

#### Through our website:

1. Visit <http://cafamerica.org>
2. Click "Give Now"
3. "Give a single gift"
4. "Search and Give to organizations in the CAF America Database"
5. Type the name of the desired organization
6. Click "Donate Now"
7. Fill out the form accordingly and click Submit
8. Enter credit card information and click Submit
9. Wait for the confirmation page – do not re-click submit or refresh the page as you may be additionally charged.
10. An e-mail confirmation will be sent to you for tax deduction purposes.

**By wire transfer:**

1. CAF America requires that all wire transfer donations be accompanied by a gift form that may be e-mailed or sent by post.
2. Use the banking information below.

“(Organization) has been vetted and approved to receive grants from CAF America; if you are a US donor wishing to make a tax-deductible contribution to support us, you may give to CAF America and recommend that the grant be made to (organization).”
